Filling out this form is not a guarantee that the non-custodial parent will be charged. It is ultimately up to the Ottawa County Prosecutor's Office whether the non-custodial parent is charged or not.

Please complete as much of the information as possible, and return to the Friend of the Court.

Please provide the most recent photograph you have of the non-custodial parent. Please also provide any supporting documentation that shows the non-custodial parent may have the ability to pay, but is choosing not to. Examples of helpful documentation would be Facebook messages or text messages about money being made, work being done, not paying child support, etc.

Once a criminal charge has been issued, you cannot have it dropped or reduced. Any charge reduction is at the discretion of the Ottawa County Prosecutor's Office.
