TO LOCATE WILL/BURIAL DEED

- 1. Banks/financial institutions typically seal the safe deposit box of a deceased person. Even if you have the key to access the box, you may find that you will not be allowed to open the box of the deceased person. You may want to open the box to look for a will or burial instructions. You can do this by filling out the top portion of the attached "Petition and Order to Open Safe Deposit Box to Locate Will or Burial Deed", PC 551 (note that the box must be located in Ottawa County) and sending it to the Probate Court with a \$10 filing fee (payable to the Ottawa County Probate Court).
- 2. When the Judge signs the order, the Court will send you a certified copy so that you can bring it to the bank/financial institution to examine the contents of the box. The enclosed "Safe Deposit Box Certificate and Receipt", PC552 must be taken to the bank/financial institution so that the petitioner can fill it out at the time the contents are examined. It must be returned to the Court within seven (7) days of opening the box.
