ENCROACHMENT AGREEMENT APPLICATION

An Encroachment Agreement is required whenever a property owner would like to encroach (place a permanent structure) in a drain easement. Examples requiring an agreement include, but are not limited to: installing fences, accessory buildings, signs, pools, some landscaping features, etc.

- The application must be completely filled out, and accompanied with a detailed plan or sketch outlining the proposed activity.
- The Commissioner will determine if a letter from a professional engineer, hired by the property owner is required. This needs to detail the encroachment request, the impact this will have to the drainage system in place, including all specific information regarding installation of permanent structure being placed within the easement. In addition the letter also needs to include the impact this will have on neighboring properties.
- There is a fee of \$50.00 payable to the Water Resources Commissioner's Office for processing the agreement; also you will need to provide a check payable to the Ottawa County Register of Deeds to get the agreement recorded. Recording fee is determined based on the number of pages in the document. The amount will be determined & given with instructions when you receive your agreement paperwork.

Remember: Issuance of the Agreement does not alleviate you from obtaining other necessary permits.
