TO THE WATER RESOURCES COMMISSIONER OF THE COUNTY OF OTTAWA


Petitioner, **City of Coopersville** hereby petitions for cleaning out, relocating, widening, deepening, straightening, tiling, extending, consolidating with other drains and adding branches of the drains known and designated as the **Eagle Ridge Estates #2, Eagle Ridge Estates #3, Eagle Ridge Estates #4 (which includes Eagle Ridge Estates #5) Drain**, located and established in the **City of Coopersville**, in the County of Ottawa, State of Michigan. The proposed consolidation shall include land not within the original Drainage Districts.


Petitioner is a municipality and this petition has been authorized by its governing body, as evidenced by the attached resolution. Petitioner is a municipality which will be liable to assessments at large for at least a percentage of the total amount to be assessed for the cost of the proposed drain project.

Your petitioner further shows that the said drains need cleaning out, widening, deepening, straightening, relocating, consolidating, and adding branches. The proposed work is for the reason that there are flooding issues within the drainage area and the said cleaning out, widening, deepening, straightening, relocating, consolidating with the other drains and adding branches of such drains is necessary to the public health of the properties and residents in the **City of Coopersville**.

This Petition is made pursuant to Chapter 8 of the Michigan Drain Code of 1956 as amended (MCL 280.196 *et.seq*).

**A RESOLUTION TO SUBMIT A PETITION TO THE OTTAWA COUNTY  
WATER RESOURCES COMMISSIONER TO MAINTAIN, IMPROVE, AND ADD  
EAGLE RIDGE DRAINS TO THE DRAINAGE DISTRICT**

WHEREAS, The Eagle Ridge Estates #2, Eagle Ridge Estates #3 Drain and the Eagle Ridge Estates #4 Drain are established county drains serving lands in the City of Coopersville; and

WHEREAS, drainage issues exist within the Drainage Districts, and resolution of the drainage issues requires the consolidation of the Drains and the Drainage Districts under the Drain Code; and

WHEREAS, these Drains are necessary for the public health of the City and that the City is liable, at large, for a percentage of the total amount assessed of the cost of the proposed work; and

NOW, THEREFORE, BE IT RESOLVED THAT this City Council deems that a petition be submitted to the Ottawa County Water Resources Commissioner for the maintenance, improvement, and consolidation of the Eagle Ridge Estates #2, Eagle Ridge Estates #3, and Eagle Ridge Estates #4 Drainage Districts as authorized under the Michigan Drain Code of 1956, as amended.

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized to execute such petition and that a copy of this Resolution shall be attached thereto. The City will submit a petition pursuant to Chapter 8 of the Michigan Drain Code.




