Respite Services

COMMUNITY MENTAL HEALTH OF OTTAWA

Community Mental Health of Ottawa County

(CMHOC) provides temporary or short-term care, known as respite services, for adults and children with developmental disabilities and children with serious emotional problems. Respite care can be used on a regular or occasional basis, depending on your family's needs, and can be provided by a family member, friend, or skilled care provider.

Once it is determined that you are eligible for CMHOC services, your family will be asked to complete a brief survey about your needs with our Respite Specialist. The amount of respite dollars you receive is determined by this assessment.

With respite services at CMHOC, your family can choose your provider of respite care and how you want to spend your respite dollars. With CMHOC respite services, all related employment tax withholding obligations and tax reporting requirements will be handled by the fiscal intermediary you select. Your provider will receive reimbursement by submitting their voucher to CMHOC for approval. We will forward the voucher to a fiscal intermediary for payment processing. Checks to providers are distributed by the fiscal intermediary on a weekly basis.

What Is Respite?

Relaxation

Respite gives families peace of mind, helps them relax, and renews their humor and energy.

Enjoyment

Respite allows families to enjoy favorite pastimes and pursue new activities.

Stability

Respite improves the family's ability to handle daily responsibilities and increases stability.

Preservation

Respite helps preserve the family unit.

Involvement

Respite allows families to be more involved in community activities.

Time Off

Respite allows families to take a needed vacation, spend time together, or time alone.

Enrichment

Respite makes it possible for family members to enrich their own growth and development.

Important Information to Note

It is your responsibility, and in the best interest of your family, to monitor the funds you use through respite. If you exceed the limits outlined below, your eligibility for respite dollars could be at risk. The maximum amount a respite provider may receive is \$12 (twelve) per hour or \$150 (one hundred fifty) per day.*

- All respite care providers within a calendar quarter (January to March, April to June, July to September, and October to December) must not earn more than \$1,000.**
- Any single respite care provider within a calendar year (January thru December) must not earn more than \$1,700.**
