

Today the program is a **year-round opportunity** for families, schools, businesses and community-based groups **to conduct litter monitoring and water quality testing** along the Great Lakes shorelines.





The Adopt-a-BeachTM Program

- 1991 begun as part of the International Coastal Cleanup
- 2003 year-round program launched
- 2008 Adopt-a-Beach™ next steps aligned forms with EPA Sanitary Survey
- Partner with beach health officials






2009 Adopt-a-BeachTM Litter Results: Ottawa County by percentage






Project partners

Lend A Hand Program

Ottawa County Health Department

US Geological Survey Division

- Team visited 2 beaches 2 times weekly
- Trained by Ottawa County Health
 Department to collect and prepare water
 samples for bacteria
- •Water samples analyzed in the lab along with Petri film method used by Adopt-a-Beach ™ program
- Trained by USGS intern on collecting modeling information



Adopt-a-BeachTM Next Steps



- •Expand the Adopt-a-Beach™ program into areas not currently served
- •Focus on beaches in AOC's with BUI's for beach closures
- Develop partnerships with beach health officials in target areas



Adopt-a-BeachTM Next Steps




- Develop and implement Tiered system for volunteer monitors
 - •Tier Two increased beach visits, higher level of training
 - •Tier One more flexibility with beach visits
- •Develop and deploy improved online data entry system with a web interface for the public to view results
- Work with volunteer monitors and beach officials to identify actions to improve beaches
