#### **DISCUSSION ITEMS**

#### A. FINANCIAL REVIEW

Huttenga shared that the updated financial statements were not available. Huttenga explained the tentative plans for the available funds and how the funds could be used for existing and future projects.

#### **B. FARM UPDATES**

Huttenga is preparing the RCPP parcel application and will submit the applications on or before January 23, 2023 for the Veldheer property, +/- 35 acres in Olive Township, and the Mark Jongekrijg property, +/- 94 acres in Zeeland Township. Lamer submitted the ACEP-ALE application for the Holstege property, +/- 36 acres in Zeeland Township. The ACEP-ALE recipient grant award could be announced by early to mid-2023. The Bronkema property closed on Monday, December 19, 2022. Lamer will schedule the Bronkema sign reveal date for Spring of 2023.

The press release will announce the Farmland Preservation Program is accepting applications now through March 31, 2023 and will also include that the Bronkema farm is the sixth farm officially preserved into the Purchase of Development Rights (PDR) program in Ottawa County.
