Spring Lake Township	1 (AV) Pct. 2	List of voters had 1 more than number of ballots tabulated	Yes	Clerk and Election Inspectors counted ballots and retabulated the precent ballots. They ended up balanced.
Robinson Township	Pct. 2	List of voters had 1 more than number of ballot tabulated	Yes	After review of remarks, a ballot was issued to a voter's relation who did not vote, the ballot was not cast.
Robinson Township	Pct. 3	List of voters had 1 less than number of ballots tabulated	Yes	After review of remarks, a poll inspector ran a blank "test" ballot through the tabulator at the beginning of the day.
