IMPORTANT NOTICE TO CONSERVATOR'S PLEASE READ CAREFULLY

In accordance with Michigan Court Rule 5.409(C) (4) conservatorship of minors in which the money is ordered to be held in a restricted account will no longer require an annual accounting but rather an annual verification of funds. The following is an excerpt from the above mentioned Court Rule:

UNLESS OTHERWISE ORDERED BY THE COURT, NO ACCOUNTING IS REQUIRED IN A MINOR CONSERVATORSHIP WHERE ASSETS ARE RESTRICTED OR IN A CONSERVATORSHIP WHERE NO ASSETS HAVE BEEN RECEIVED BY THE CONSERVATOR. IF THE ASSETS ARE ORDERED TO BE PLACED IN A RESTRICTED ACCOUNT, PROOF OF THE RESTRICTED ACCOUNT MUST BE FILED WITH THE COURT WITHIN 28 DAYS OF THE CONSERVATOR'S QUALIFICATION OR AS OTHERWISE ORDERED BY THE COURT. THE CONSERVATOR MUST FILE WITH THE COURT AN ANNUAL VERIFICATION OF FUNDS (FORM pc 669) ON DEPOSIT WITH THE COURT WITH A COPY OF CORRESPONDING FINANCIAL INSTITUTION STATEMENT ATTACHED.

****Enclosed you will now find form PC 669 Proof of Restricted Account and Annual Verification of Funds on Deposit (Conservatorship of Minor) rather than the regular accounting forms that you may have previously filed with the Court. The enclosed form MUST be completed by a representative of the FINANCIAL INSTITUTION where the funds are on deposit and NOT the conservator, please also attach a copy of the statement that corresponds with the information given on form PC 669 when presenting to the Court for filing.
