**RESIDENTIAL HOME STARTS (Mark Knudsen)**

Third quarter residential home starts data have been released. These data reveal that the number of single family home starts in Ottawa County through the third quarter of 2010 has surpassed the total number of single family home starts for all of 2009. Multi family home starts, however, continue to be below the 2009 level. The attached file depicts the number of residential home starts in Ottawa County as well as each local unit of government from 2003 through the third quarter of 2010.

**UNEMPLOYMENT STATISTICS (Mark Knudsen)**

Jobless rates continue to show improvement, with Ottawa County's monthly unemployment rate down to 11.1% in September from a high of 14.0% in March. Unemployment rates are also down in each of the three largest local units of government (Georgetown Township, Holland Township, and the City of Holland). The attached files include the annual and monthly unemployment rates for Ottawa County, the three largest local units of government, Michigan, and the U.S.
