Motion and Order to Show Cause for Violating Valid Personal/Foreign Protection Order

Use this form if the respondent has violated your valid personal/foreign protection order and you want the court to order him/her into court to answer a contempt charge.

By filling in this form, you are asking the court to order the respondent to court to answer a contempt charge. You must have the form dated and signed by a notary of the public.

- **Step 1:** Fill in the case number only if you are filing this form in the same court where you got your order. If you are filing this form in a court other than the one that gave you your valid personal/foreign protection order, you must provide a copy of the original personal protection order and proof of service.
- Step 2: Fill in the "petitioner" and "respondent" as it appears in your order (i.e. form CC 376 or CC 380).
- **Step 3:** Write in the date of your valid personal/foreign protection order. Get this information from your order. If Ottawa County is not the county where the personal/foreign protection order was issued, you must attach a copy of that order, along with either proof of service on or notification to the respondent of this order.

<u>Civil contempt</u>: Civil contempt is intended to ensure future compliance with a court order. If the court finds a violation of the court order by a preponderance of the evidence, the court may assess fines and even jail time to ensure compliance. An individual can resolve the civil contempt issue by following the court order.

<u>Criminal contempt</u>: Criminal contempt is simply punishment for past violation of a court order. The court must find, by a "beyond a reasonable doubt" standard, that an individual has violated a court order and can assess fines or jail time. **May ONLY be filed by an attorney**

- **Step 4:** On the attached page, explain in as much detail as possible what the respondent has done to violate the personal/foreign protection order. You must attach any supporting documents.
- **Step 5:** Bring your completed forms and all copies to the court clerk's office in Grand Haven. The court clerk's office is located on the 3rd floor of the courthouse (room 320). You may sign the paperwork in front of a court clerk, as they are notaries.
- **Step 6:** On the Order to Show Cause for Violating Valid Personal/Foreign Protection Order you must fill out the Petitioner and Respondent's name, address, and phone number. The Court will fill out the remainder of the document.
- **Step 7:** After filing the documents with the clerk's office, the court will review the motion and order to show cause and sign the order. You, as the petitioner, must pick up the documents and have the other party, the respondent, served. You may come into the clerk's office to pick up the copies, or you may provide a self-addressed stamped envelope and the clerk will mail the documents to you for you to have the respondent served. You, the petitioner, **may not** serve the respondent. You must have a third party or process server serve the respondent in person or by registered mail. The respondent must be served at least seven days prior to the hearing.
