Notice of Letting

OTTOGAN INTERCOUNTY DRAIN – CHANNEL IMPROVEMENT PROJECT (Allegan and Ottawa Counties)

The Ottogan Intercounty Drain Drainage Board will meet on the above date, time and location to receive construction bids for the Ottogan Intercounty Drain. Bids will then be opened and publicly announced.

The Ottogan Intercounty Drain – Channel Improvement Project will be let in 1 section. The work involved for the project includes placing 458 linear feet of armored edge, lifting 110 linear feet of existing sheet piling, installing 10 remedial tie-backs, filling 15 cy of voids, and patching 47 holes in the existing sheet piling; along with removals, job site control, erosion control and restoration.

This Notice of Letting, the Plans, Specifications and Bid Proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents on file as of Monday, June 28, 2021 at the offices of the Ottawa County Water Resources Commissioner and the Allegan County Drain Commissioner and available to interested parties. The two county offices' contact information is listed below. Bids will be made and received in accordance with these documents.

Bidding Documents, including plans and specifications, may be obtained via e-mail by contacting DavidLSchultz@Charter.net at Schultz Land & Water Consulting, Inc. Hard Copies of the Bidding Documents may also be obtained upon payment of a \$50.00 non-refundable deposit.

A bid deposit of at least 5% of the bid amount shall be required for this project when submitting the Bid Proposal. The Bid deposit may be in the form of certified check, cashier's check, or bid bond.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.
