The Ottawa County Water Resources Commissioner will electronically meet on the above date and time to receive construction bids for the Crockery Lake Drain. Bids will then be opened and publicly announced. Due to the ongoing coronavirus public health crisis, the construction bids received will be opened and read publicly through Zoom at the participation information provided below.

Electronic participation will be conducted through Zoom. The Bid Letting may be accessed through any device supporting the Zoom app, which includes many computers, laptops, smartphones. The Crockery Lake Drain will be let in 1 section as follows, each section having the length, average depth and width as set forth:

Work shown on the drawings and specified herein generally described as: Construction of 325 lineal feet of open drain construction having an average width of 4-feet and average depth of 3-feet, 870 lineal feet of open drain construction and bank shaping having an average width of 6-feet and average depth of 5-feet, 125 lineal feet of step pool construction, plain riprap, and surface restoration.

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file at the Office of the Ottawa County Water Resources Commissioner and available to interested parties. Bids will be made and received in accordance with these documents. Bidding Documents, including plans and specifications, may be examined at the following locations:

Copies of Bidding Documents may only be obtained from the offices of Eng., Inc. upon payment of a \$20.00 non-refundable deposit. An additional non-refundable charge of \$10.00 will be required for sending out Bidding Documents for each Contract. Digital copies of the drawings and specifications will be provided to potential bidders at no charge.

A security deposit in the form of a cashier's check, money order, certified check or bidders bond shall be submitted with any bids. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.

The Day of Review is an opportunity to review the tentative apportionment of benefit for each parcel and municipality within the Crockery Lake Drain Drainage District.

The Day of Review is being via remote electronic access in accordance with the Open Meetings Act and federal and state agency recommendations in relation to the ongoing COVID-19 public health emergency. **YOU ARE NOT REQUIRED TO ATTEND THE DAY OF REVIEW.** 

Electronic participation will be conducted through Zoom. The Day of Review may be accessed through any device supporting the Zoom app, which includes many computers, laptops, smartphones. Users on a computer or laptop will be given the option to join the meeting through a web browser without downloading the Zoom app. Additionally, individuals may call into the Day of Review by telephone.

#### **Prior to the Day of Review:**

- **Telephone**. You may submit questions and comments prior to the Day of Review by calling the Water Resources Commissioner's Office at (616) 900-9818.
- **Zoom.** We recommend downloading the Zoom app to your device to ensure there is time to obtain technical advice prior to the Day of Review.

- The Water Resources Commissioner, engineers and/or other staff members will be available to assist individuals throughout the day and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review.

- The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

#### After the Day of Review:

• You may appeal the Water Resources Commissioner's determination of apportionments to the Ottawa County Probate Court within ten (10) days.
