#### DISCUSSION ITEMS

1. Gordon Nederveld, Nederveld Associates, Inc. presented to the committee information for increasing the county surveyor's contractual fee for \$10,000 from \$25,000 to \$35,000. Of the \$10,000 requested, \$5,750 would be for cost-of-living increases. There has not been an adjustment in this fee for seven years. The remaining \$4,250 would be for additional county surveyor involvement in the overall remonumentation program. Mark Knudsen questioned whether the work load, time involved, and who will be involved, would justify the dollar increase being requested by Nederveld and Associates. Ms. Visscher requested the staff to be able to present updated stats and facts of the issues being presented to the committee so that issues may be dealt with at the time of the presentation.

2. Mr. Johnson presented to the committee the background regarding the loss of revenue due to utility property multiplier changes. Personal property primarily consists of machinery, equipment, furniture and fixtures that are owned by commercial, industrial and utility enterprises. The evaluation multipliers consist of two components; an appreciation to trend historic acquisition costs to the current day costs, and a depreciation component to recognize the loss in the value of the asset due to depreciation.
