## APPROVED PROCEEDINGS OF THE OTTAWA COUNTY BOARD OF COMMISSIONERS JANUARY SESSION - SECOND DAY

The Ottawa County Board of Commissioners met on Tuesday, January 9, 2001, at 1:30 p.m. and was called to order by the Chairman.

Mr. Swartout pronounced the invocation.

The Clerk led in the pledge of Allegiance to the Flag.
