SUBJECT: DISCUSSION ITEMS

- 1. 2003 General Fund Budget Using the tax levy set at 3.4 mills, Rosemary Zink explained the General Fund. Total expenditures are \$53,479,813 and total revenue is \$53,589,802 leaving the fund balance at \$109,989. These totals include all 2003 personnel and equipment requests.
- 2. 2003 Budget for the Special Revenue, Debt Service, Capital Projects, and Permanent Funds Rosemary Zink reviewed the special revenue funds with the committee. There are no 2003 projected fund deficits.
- 3. Windmill Island Administration said Holland City has been lobbying some of the Commissioners. No letter has been received from the City. Greg Rappleye said the dollars set aside for Windmill Island were limited to sewer and water. Consensus of the committee is to have Greg send the City a letter addressing the status of the project and would like a response by the next Finance and Administrative Committee Meeting in two weeks. Mr. Rycenga would like to see \$365,000 to the Project Fund, \$300,000 to Wetlands Cleanup and \$300,000 to the Low Interest Revolving Fund. He asked the committee to think about it and have it brought back next month as a discussion item.
