Ottawa County Data Book Demographics Section 2003 Edition- Mark Knudsen presented the 2003 Edition of the Data Book Demographics Section.

Planning and Grants Issues- Mark Knudsen touched on various issues the Planning and Grants Department is working on. The issues discussed are as follows:

- The "Citizen's Planner" will be available by the fall. This will require a six week training program before an individual becomes a planner.
- Working on updating their web site.
- The North/South Corridor is almost finished. A new draft will be available this Friday.
- Starting work on the M-104 Corridor Study, hoping to have this wrapped up by January 30, 2004.
- The Non-Motorized Pathway Study is beginning to move forward. Have applied for a 3-year grant.
- Smart Growth finished in Blendon Township two weeks ago. Robinson Township to replicate.
- Urban Smart Growth will depend on revenue sharing.
- Working with the Road Commission on the road salt issue.
- Finalizing report for Link Michigan in the next 30-60 days.
- The County Development Plan was last updated in 1992. Hoping to have a new plan developed in February 2004. Looking at a more progressive approach.

The Report of the County Administrator was presented.

Several Commissioners reported on meetings attended and future meetings to be held.
