1. Bio-Terrorism Smallpox - A powerpoint presentation was presented by Dr. Heidel on Smallpox. Vito Palazzolo explained that Ottawa County and the Health Department are in the planning stages with the State of Michigan. Phase I will be starting and it involves the Health Department staff and hospitals staff. Ottawa County is in Region 6 and Phase I will be done in Kent County. The 600-650 people in Phase I that will be vaccinated are all voluntary. Phase 2 will start in March or April. There will be 60 - 70 thousand responders in Phase 2 which consists of EMS, firefighters, police (local, state, and city), and hospital personnel. Before Phase 2 starts, Vito will report back to the Health and Human Services Committee. Phase 3 will be offered to the general public in 2004. Information will be available on the Health Department's web site.
