SUBJECT: DISCUSSION ITEMS

1. Emerald Ash Bore - Chuck Pistis explained a new exotic beetle from Asia called the Emerald Ash Borer was discovered feeding on ash trees in southeastern Michigan. State officials issued a quarantine on all ash trees and ash wood products in southeastern Michigan to prevent and control the spread of the Emerald Ash Borer. The Emerald Ash Borer has a one year life span. There has been one unconfirmed sighting in Ottawa County. A possible compensation program may be started so Chuck suggested keeping records for damages caused by the Emerald Ash Borer.

Chuck also handed out the "Citizen Planner Program" which is a land use training and certificate program for volunteer land use decision makers. He encourages the committee to distribute the registration form to those who are interested.

- 2. Building Projects Update The building projects update was presented by Mark Scheerhorn.
- 3. HAZMAT Greg Rappleye drafted the Hazmat Materials Response Team Agreement. Greg is hoping to have approvals from the townships finished by the end of the week. Scholten and Fant is raising some issues for some of their clients. They would like to see the agreement move complicated with the county having less authority. The documents requires 100% participation.
