Work Session Items

A. Lobbyist Update - Mark Knudsen introduced Gary Reed. He reported on the following:

- 1. New formula for Revenue Sharing.
- 2. New Drain Code being worked on.
- 3. Transportation issues.
- 4. Road salt issue.

5. Discussion on next year's budget, added fees, revenue sharing costs/acts, and other cuts.

B. Ionia Jail Diversion for Mentally III - Gary Rosema introduced Sheriff Duane Dennis from Ionia County. Sheriff Dennis spoke on how they reversed the process of picking up the mentally ill and putting them in the County Jail. He discussed the collaborative effort between the Sheriff, Prosecutor, Board of Commissioners and Mental Health Director. Police officers were given a training program on alternatives to incarceration for the mentally ill.

C. Jail Medical Services - Vito Palazzolo explained the Health Department has been responsible for providing Jail Health Services duties to the inmates in the county jail. As part of the Health Department's reorganization plan, Jail Health Services were also reviewed. Noted were liability issues with medications and staffing levels. It is recommended the Jail Health Services be contracted out to a private health care provider.

D. Fiber Optic Update - A fiber optic update was presented by Mark Scheerhorn and Steve Namenye. It was requested an economic rate of return on the wireless vx. fiber vx. DSL as presently known be done.

E. Technology Demonstration - Barry Kantz, Jon Overway, Steve Kraai, Steve Baar, Kevin Bowling and Daniel Krueger presented rationale for imaging regardless of the archival issues.

As time ran on, Mr. Swartout suggested to Kevin Bowling he present the e-filing issue at the next Board meeting.

Mr. Swartout read a letter from an employee regarding working for the county.
