#### SUBJECT: DISCUSSION ITEMS

- Resolution creating Multi-Purpose Collaborative Body Greg Rappleye presented the background information on the 1995 Resolution creating the Multi-Purpose Collaborative Body. He will be looking at the rules from 1995 and see if they still apply today. Vito Palazzolo will review the resolution with the Multi-Purpose Collaborative Body and meet with Greg with the suggested changes. Changes will then be brought back to the Health & Human Services Committee.
- 2. Affordable Housing in Ottawa County Dennis Swartout asked this Committee to look at the concerns of affordable housing in Ottawa County. Cathy Simons believes there will be a lot of foreclosures in future years due to balloon interest rates.

Ms. Visscher would like staff recommendations on what appropriate direction needs to be taken. Alan Vanderberg reported the county had looked at becoming an Urban Entitlement County. Mark Knudsen's staff did a survey and about half of the units responded and half of those were not interested. The Administrator has talked with a couple of cities who would at least be interested in resuming talks and finding out more about it. Staff to look at what other counties are doing and report back to committee in two months.

- 3. Multi-Purpose Collaborative Body Minutes The Multi-Purpose Collaborative Board Minutes were presented by Vito Palazzolo.
- 4. Child Abuse Prevention Cathy Simons handed out "Child Sexual Abuse: A Handbook for Ottawa County Churches". She reported churches can do lien checks through the Sheriff's Department. Loren Snippe reported a meeting has been scheduled for April 27th for pastors to go over practices the churches should follow. He reported the Smeyers are initiating township Boards to address building codes for churches. This

issue will be brought back to committee as soon as Mark Knudsen is ready to address this issue.

5. Department Reports -

CMH - Vito Palazzolo announced the retirements of Jim Szejda, Environmental Health Services Director, and Jack VanEerden, Environmental Health. He reported the Health Department is working on new presentations and programs.

Lakeshore Coordinating Council - Karen Youngs-Hartley handed out the preliminary profile from the last fiscal year on substance abuse. She reported with changes in the State Medicaid formula calculation for substance abuse services, Ottawa and Muskegon Counties will be receiving an additional \$19,000 a month more.
