- 2. Child Abuse Prevention Services (update) Loren Snippe reported Gary Rosema and Steve Crumb will be putting together protocol on what steps need to be taken to do background checks. He stated the work is in process at this point and hoping to have it completed by April. On April 27th, there will be a conference for churches dealing with safety, abuse, and the church.

Mark Knudsen reported the county can only serve on an advisory level. The Planning Commission will pass a resolution and forward it to the local units encouraging the local units to look at zoning ordinances.

3. Department Reports -

CMH - Gerry Cyranowski reported Muskegon/Ottawa CMH took a 2.4 million Medicaid hit. They are working on how they can absorb this loss without effecting service. With reduction in funding, more regulations from the feds have been coming down.

A work group of about 30 people will begin working on the results from last fall's CMH Needs Assessment and coming up with recommendations.

Gerry reported the first Micro-Enterprise has been running for 5-6 weeks. It's a coffee shop in the James Street lobby and it's doing very well.

Michigan Works! - Cathy Simon reported the Community Action Advisory Board sent a letter to Dennis Swartout, Chairman of the Board of Commissioners, thanking the Board for their support with the CDBG Grant.
