#### SUBJECT: DISCUSSION ITEMS

- 1. Revised Edition of the 2001 Health Section of the Ottawa County Data Book Mark Knudsen stated the Health Section of the Data Book has been updated with colored graphs, new templates, etc. making the cost of the book \$40. He passed out CDs of the Health Section 2001 edition and Demographics 2003 edition. These can be purchased by the public for \$5. The Data Book is also available on the Planning and Grants web site.
- 2. Jail Gatekeeper / Cognitive Behavior Therapy Program Mark Knudsen gave an overview of the new Jail Gatekeeper position. A committee was formed and strategic planning took place to form the Cognitive Behavior Therapy Program which provides community-based, in-kind services for in-jail and post-jail treatment programs for inmates. Sherry Cole reported the target population are inmates with mental illness, sex related charges, anger/violence related charges and substance abuse charges.
- 3.
