#### SUBJECT: DISCUSSION ITEMS

2006 Budget Review - General Fund - June Hagan, Fiscal Services Director, explained the 2006 preliminary figures for the 2006 General Fund Budget. A handout of the Five Year General Fund Budget Projections was distributed. The 2006 budget will be presented to the full Board at the first meeting in October and approved at the second meeting.

#### 2. Funding Requests:

- Ottawa County 2-1-1 The Administrator explained 2-1-1 of Ottawa County will provide service to a. the county at a cost of \$60,000 annually. Administration is recommending \$15,000 - \$20,000 but not \$60,000. He is not looking for approval at this point just ideas. Ottawa County United Way is not supporting this program. There has been talk about regionalizing the 2-1-1 program. Lisa Stefanovsky is willing to step forward and assume a role on the 2-1-1 Board as the former Health Officer served on the Board.
- Lakeshore Coordinating Council (LCC) The Administrator gave the background for the LCC b. request and explained the August 3rd letter he received from Karen Youngs Hartley requesting approval of PA2 funds at a reduced amount of \$50,000.

Bev Kuizema explained the funds would be used to support the specialized services for courtreferrals and services for low-income, uninsured clients in need of integrated treatment for cooccurring addiction and mental illness. Handouts of how PA2 Funds are used in Ottawa County were distributed by June Hagan.

LCC is also requesting funding for Total Trek. More clarification is needed.

Sexual Assault Nurse Examiner Program - Prosecutor's Office - The Administrator wanted to alert C. the Committee of funds requested. This program is tentatively in the 2006 Prosecutor's Budget. Copies of this program will be distributed to the full Board at the Work Session.
