- 1. Lakeshore Coordinating Council 2006 Budget Request June Hagan reported she contacted LCC in the spring and Karen Youngs Hartley, LCC Executive Director, told her LCC would not be requesting funds in 2006. LCC is now requesting funds. PA2 funds can only be spent for substance abuse. The County will continue to spend the 50% on programs needed for services for the citizens of Ottawa County.
- 2. Budget Update June Hagan explained the 2007 Updated Budget Calendar. Fiscal Services is finishing up meetings with the departments this week. June stated the general fund which includes department requests and personnel requests is \$5.2 million over revenue. She reported the departments are aware of possibly coming back and making cuts from their requests. Dave Hulst, IT Director, went back through the IT requests and cut about \$90,000. The plan at this point is a hiring freeze except for Holland courthouse where clerical positions may be necessary. The Administrator reported the County could be looking at serious cuts for 2008.
