Health Department – Dr. Heidel reported Kent County is working on a regional morgue. A consultant has been hired. A proposal will go before the Kent County Board in October which looks like it will be a stand alone facility.

Community Mental Health – Gerry Cyranowski reported the survey team from the Michigan Department of CMH is working on the biannual survey. The opening conference was held in Muskegon last Monday and will adjourn next Thursday in Ottawa County. He also reported that the Supportive Housing Project is set to begin construction on three apartment complexes located in Grand Haven, Holland and Zeeland. CMH has been working on this for the past 6-7 years.
