#### SUBJECT: DISCUSSION ITEM

 General Fund Surplus – June Hagan, Fiscal Services Director, explained that there is just over \$2 million in the general fund surplus and that the numbers are just estimated at this time. There will be a discussion at the April Finance and Administration Committee meeting dealing with what to do with the surplus funds. Administration recommend fully funding the fund balance stabilization fund, reserve \$412,000 for the Remonumentation Program, and reserve the remaining 1.2 million in the general fund for building projects, if needed.
