A. Contract Management

- 2. It was recommended that the Plan of Correction include future prevention to stay in compliance, also, copies of the Plan of Correction will be sent to licensing.

  - 1. Comment boxes were place at the desks in the entrances, due to this there were more comments then what was anticipated, Kelly will report on them in August.

- C. Consumer Services Report
  - 1. The Walk a Mile in my Shoes Rally held in Lansing on May 25 was a success. Over 800 people attended. More than 50 consumers from Muskegon and Ottawa counties were able to help raise awareness.
  - 2. 3000 Mental Health "seed cards" were distributed throughout the county. Elizabeth thanked Kelly stating that her flowers looked great.
  - 3. The "Out of the Shadows" television broadcast sponsored by Muskegon and Ottawa County CMH was a success.
  - 4. Grand Haven officially has a drop in center, Westshore Drop in Center. They have applied for a grant.
  - 5. Grand Haven CBE is being spruced up. Port City Paint and Sherwin Williams donated paint, Elder- Bierman supplied the workers. The owner of the building will provide plastic wallboard and put it up.
