#### A. Contract Management

- Provider Report Card: Kathy Coffey reported the following contracts will be renewed Pathways, Community Action Agency, and HUD. CWIT is temporarily on hold till funding is approved. Kathy reported that we would be working on a contract with Muskegon effective 10/1/2007 for Community Living Supports. Pathways-25 out of 50 responses were received with the satisfaction survey that was sent. Eleven (11) rating services as excellent, 10 rating services as good, two (2) rating services as fair and two (2) rating services as poor. The negative comments and poor ratings were due to untimely payments and poor communication.
- Quarterly Site Visit Report (January-March, 2007)
   Kathy updated the committee that Central has the lowest score. Kathy discussed that homes surveyed this quarter had expired meds, primarily topical and over the counter. She also discussed that updated TB tests needed to be at the home on file. The staff also needed to keep receipts when purchasing anything for the consumers.
- Consumer Comments
  Kelly Sall reported two comments had been received in April 2007. The first one on 4/9/07 with a rude employee and it had been handled as the employee had left the agency. The second comment was a positive feedback from a consumer at the

clubhouse. Kelly also commented on the upcoming "Walk a Mile in My Shoes" to the committee. She reported that she had a few seats left on the bus.

- B. CMH Recipient Rights Report
  - Briana reported that in April 2007 eleven (11) complaints were opened and thirteen (13) were closed. Three hundred and six (306) Incident Reports were received by the Recipient Rights Office in April 2007. There were no Sentinel Events to report and also no deaths to report.

  - Tracy reported back to the committee that there were no changes that they had hoped for in the performance indicators that she had reported on last month.
