CMH SERVICE PRESENTATION

There were no service presentations this month.

QUALITY IMPROVEMENT

Outcome Measures in Service Contracts –

Mr. Cyranowski requested input from Committee members regarding ideas for outcome measures to be included in contract summaries. Discussion ensued regarding the measurements for quality of service that are in place.

PLANNING

Pioneer Resources Transportation Contract –

Mr. Van Ommen commented on the Transportation Committee Meeting held on January 17, 2007.

Greg Scott and Tiffany Bouwman from Pioneer Resources presented information regarding the services provided by their agency as well as the transportation system in Ottawa County and answered questions.

Mr. Scott apologized for Pioneer's failure to provide complaint information in a timely manner. He provided an overview of the process in place for logging and addressing complaints. Driver training was also discussed. It was noted by Mr. Hofman that all drivers have knowledge of CPR, First Aid, and Recipients Rights.

Holland Hospital Clinical Services Contract -

Mr. Cyranowski noted that this contract is coming due at the end of March, 2007, and given the concerns that have been expressed regarding this contract, he was seeking approval to move forward with negotiations. He provided a history of the development of the contract as well as detailed information regarding the contract and services provided by Holland Hospital.

Transportation

Information regarding Transportation Coverage for Medicaid Beneficiaries was presented to the Committee for information. Mr. Cyranowski asked that Committee members review this information and return with questions at February's meeting.

In response to Ms. Gretzner's concerns that consumers are not informed on how to make complaints, Mr. Hofman provided information about the avenues offered to consumers to lodge complaints.

Mr. Van Ommen suggested to Pioneer Resources staff the possibility of providing Board Members with a pass that would permit them to access Pioneer's services in order to make an assessment of quality. Mr. Cyranowski suggested that this be taken to the Transportation Committee.
