# NEW BUSINESS

- Severe Weather declarations
  - Ottawa County has received a Presidential Disaster Declaration for damages sustained in the severe weather incident in June of 2008

    - July 23<sup>rd</sup> there will be an applicants briefing to outline the procedure for applying for damage reimbursement

- Three of the major applicants will be the Ottawa County Road Commission, the Ottawa County Drain Commission and the City of Holland.
- Ottawa County has also received an Agricultural Declaration.
  - Any producers are encouraged to contact the FSA office.

### HAZMAT/TECH RESCUE TEAM UPDATE

- Request Foods has agreed to let the Tech team use their facility for training
- Request Foods has been fined by the EPA. This money can be used by the County for programs instead of paying it to the EPA.
