Paul Sachs provided an overview of the Urban County Smart Growth project. He discussed the goals, objectives, and primary components of the project. He said the project will focus on improving vibrancy, livability and aesthetic character in the City of Hudsonville. After the presentation, Paul addressed questions from the audience.

Dan Strikwerda read two letters of support he received regarding the Urban Smart Growth Program. One was from Senator Wayne Kuipers who congratulated the City of Hudsonville for being selected to participate in the program; the other was from former Hudsonville City Manager Leon VanHarn

B. Survey of Community Support (Urban Smart Growth Demonstration Project)

A survey was distributed to all the participants at the joint meeting. Mark Knudsen asked the audience to fill out the surveys and return them to the Ottawa County Planning Commission in order to determine the level of support for the Urban Smart Growth Demonstration Project.

Public Comments:

John Wallace expressed concern with the Smart Growth "ideologies" and the free market district. He said the "Cool Cities" program contains disturbing ideas that no longer value family. Overall, Mr. Wallace is not supportive of the Urban Smart Growth Program.

Pat Meyer said she would love to see a beautiful downtown area and hopes the Urban Smart Growth Program will help achieve this.

She asked about historic preservation and overall was supportive of the program.

Mark Knudsen addressed John Wallace's concerns regarding the Urban Smart Growth Program. He said that the County's Smart Growth Project is unique to Ottawa County, and is completely different than other "Smart Growth Programs". Further, Mark said that the program will not be implemented without the mutual agreement of the Planning Commission and community.
