#### 🔀 Recipient Rights

When you are a recipient of mental health services and under a courtordered, you do NOT have the right to refuse treatment. You may ask questions, participate in the development of your Individual Plan of Service (IPOS), and discuss your treatment and treatment options with your doctor, prescriber, and other mental health professionals who are part of your treatment team.




#### Self-Determination and the PAS Workgroup
